We see our clients for the individuals they are, and how all aspects of their life experiences have impacted their behavior, emotions, and ability to learn. We provide critical and comprehensive services that honor the young person's unique needs and strengths to prevent the escalation of dangerous conditions and behaviors and set them on a positive path. We trust our young people as the experts in their own lives. By showing respect and appreciation for them at every step, we help our youth gain the skills to create and maintain supportive connections and healthy relationships in school, work, and life.



We also recognize that many of our young people, their families, and communities have been negatively impacted by biased and inequitable systems – we stand up against injustice, advocate for their rights and resources, and provide the safe space most have missed in their lives.

Since our founding in 1895 in Marin County as the San Francisco Presbyterian Orphanage and Farm – and through subsequent years as Sunny Hills Services – Side by Side has been at the forefront of best practices in child welfare, working with the most vulnerable youth in our community. Our programs use data to drive outcomes, impact and efficiency, while remaining open and responsive to the ever-evolving needs in the communities we serve.



Today, Side by Side operates in four counties – Marin, Alameda, Sonoma, and Napa – across the Bay Area, reaching nearly 2,500 children, young adults, and family members per year with much-needed services related to behavioral and mental health, early intervention in schools, LGBTQIA+ support, special education, and transitional housing for foster youth.

### **Board Opportunity**

- Have a strong interest in advocating on behalf of Side by Side and the youth we serve on community and state-wide policy measures.

## **Profile of the Successful Board Member**

Side by Side welcomes energetic board members who are, first and foremost, passionate about our mission. We seek board members who can be strong ambassadors for Side by Side through utilizing their networks and connections to help build awareness of, and support for, our impactful work. Side by Side also needs members with demonstrated leadership skills to help govern the Board and guide the organization in implementing its programmatic vision.

Successful board members are asked to support giving campaigns throughout the year, as well as fundraising events, in terms of time and/or financial commitment.

## **Board Responsibilities**

- Govern the organization by setting its high-level direction and ensure it operates in compliance with its charter, its mission, and the law.
- Act responsibly and prudently as a steward of the public trust, be an advocate for the organization in the community, and follow the organization's Governing Policies and Code of Conduct.
- Act in the best interests of Side by Side and follow its policies on avoiding and disclosing actual or potential conflicts of interest.
- Give board meetings and other activities pertaining to Side by Side a high priority, participate actively in at least one board committee, and take a leadership role in the Board's activities in line with skills and experience. Attendance in person at quarterly board meetings is required (meetings are currently being held via Zoom), while committee meetings may be attended in person or by teleconference.
- Support the organization by ensuring that it has adequate resources and overseeing its health and sustainability. As such, each board member is asked to support this responsibility by:
  1. Making a total financial contribution to Side by Side's annual fund campaign and fundraising events each year, that is personally significant and one of their highest philanthropic priorities.
  2. Attending/supporting two or more of the organization's annual fundraising events. Board members are asked to assist with solicitation of sponsors, table hosts, event ticket sales, event speakers, auction gifts, and/or wine donations.
  3. Connecting Side by Side with individuals, corporate funders, or foundations in the community to further the agency's base of support.

## **Board Terms**

Individual Board terms are three years, and may be renewed two times up to a nine-year term limit.
